1. ENVIRONMENTAL HEALTH / CODE ENFORCEMENT - 7274 Alpine Dr., Corning, RTR, California (APN: 062-130-033, Ronald Redden - OWNER) - Hearing on Notice Issued by the Enforcing Officer in Public Nuisance Enforcement Action Against the Premises

A) HEARING - Planning Commission shall hold an administrative hearing to determine whether the conditions existing on the property located at 7274 Alpine Dr., Corning, California, APN: 062-130-033, constitute a public nuisance under Chapters 9.07 and 10.16 of the Tehama County Code.

B) RESOLUTION - Request adoption of a Resolution declaring the existence of a public nuisance on the property located at 7274 Alpine Dr.. Corning, California, APN: 062-130-033; is a use or condition of the property in violation of Tehama County Code Chapters 9.07 and 10.16; is unsafe or detrimental to public health, safety, and/or welfare; ordering abatement thereof; and directing an itemized accounting of the costs incurred in abating the nuisance.

Requests for a re-hearing must be submitted within 5 calendar days for General Plan Amendments and Rezones.
