AGREEMENT BETWEEN THE COUNTY OF TEHAMA AND BUSINESS CONNECTIONS

EXHIBIT "B"

Business Connections agrees to the following terms and conditions:

1. A properly trained Business Connections' employee shall be provided to take the minutes at the monthly Fish and Game Commission meetings. This assignment is a non-prevailing wage position and said assignment is determined on meetings conducted during normal business days and hours of Monday – Friday, 8:00 am – 5:00 pm.
2. Said temporary employee will be employed solely by Business Connections and all payroll wages, State and Federal taxes, unemployment insurance and Workers' Compensation insurance shall be administered through Business Connections' payroll department.
3. Employee's gross compensation shall be a minimum of 4 hours at each day meeting.
4. Effective March 1, 2019 Tehama County Fish and Game shall be billed at an hourly rate of \$25.49 ending December 31, 2019. Thereafter, effective , January 1, 2020 Tehama County Fish and Game shall be billed at an hourly rate of \$29.43 for the duration of this contract.
5. The daily hourly billing rate shall cover all state minimum wage increases for three years.
6. Any and all evening billing rates shall be billed separately on an "as-needed" basis and shall not be included in this Agreement.
