A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF TEHAMA MAKING DETERMINATIONS AND ORDERING THAT THE COSTS OF ABATEMENT AND COSTS OF ADMINISTRATION RELATING TO THE ABATEMENT OF UNLAWFUL MARIJUANA CULTIVATION BE SPECIALLY ASSESSED AGAINST THE AFFECTED PROPERTIES AND FURTHER ORDERING RECORDATION OF NOTICES OF ABATEMENT LIENS, PURSUANT TO CHAPTER 9.06 OF THE TEHAMA COUNTY CODE AND GOVERNMENT CODE SECTION 25845

WHEREAS, in accordance with the procedures set forth in Chapter 9.06 of the Tehama County Code, unlawful marijuana cultivation occurring on each of the properties described in Attachment "B-1," attached hereto and incorporated herein, was determined to constitute a public nuisance and was ordered to be abated; and

WHEREAS, in the event that the nuisance was not voluntarily abated, the Enforcing Officer was authorized to abate said nuisance; and

WHEREAS, the nuisance conditions were not abated as ordered; and

WHEREAS, the County abated the nuisance conditions on the dates listed in Attachment "B-1," and

WHEREAS, the enforcing officer has kept an account of the cost of every abatement carried out, and has rendered a report in writing, itemized by parcel, to the board of supervisors showing the cost of abatement and the administrative costs for each parcel, which is attached hereto as Attachment "B-1"; and

WHEREAS, the total cost of all such abatements carried out was \$779.84; and

WHEREAS, the County made a demand upon the property owners listed in, and for the amounts stated in, Attachment "B-1" to reimburse the County for the cost of abatement; and

WHEREAS, the County has not received payment in full, from the property owners listed in Attachment "B-1;" and

WHEREAS, the Board of Supervisors is authorized to specially assess the costs of abatement and administrative costs against the respective parcels of land described in Attachment "B-1," pursuant to Tehama County Code section 9.06.160 and Government Code section 25845; and

WHEREAS, the Board of Supervisors is further authorized to record Notice of Abatement Lien against each the properties described in Attachment "B-1;" and
