

**FIRST AMENDMENT
TO THE AGREEMENT BETWEEN THE COUNTY OF TEHAMA
AND EXPRESS SERVICES, INC.**

This Amendment to Agreement Number 2015-145, dated June 16, 2015, by and between the County of Tehama, through its Office of Sheriff (County) and Express Services, Inc. (Contractor) for the provision of providing temporary employees, shall be amended as follows:

1. Section 3 (Compensation) of the Original Agreement is hereby amended to read as follows:

3. COMPENSATION

Contractor shall be paid in accordance with the New rates set forth in the Fee Schedule, attached hereto as Exhibit "D" effective September 12, 2017 after satisfactorily completing the duties described in this Agreement. The Maximum Compensation payable under this Agreement shall not exceed the New amount of \$40,000.00 per year. Contractor shall not be entitled to payment or reimbursement for any tasks or services performed except as specified herein. Contractor shall have no claim against County for payment of any compensation or reimbursement, of any kind whatsoever, for any service provided by Contractor after the expiration or other termination of this Agreement. Contractor shall not be paid any amount in excess of the Maximum Compensation amount set forth above, and Contractor agrees that County has no obligation, whatsoever, to compensate or reimburse Contractor for any expenses, direct or indirect costs, expenditures, or charges of any nature by Contractor that exceed the Maximum Compensation amount set forth above. Should Contractor receive any such payment it shall immediately notify County and shall immediately repay all such funds to County. This provision shall survive the expiration or other termination of this Agreement.

2. Section 20 (Exhibits) of the Original Agreement is hereby amended to read as follows:

22. EXHIBITS

Exhibit "D" of the Original Agreement is hereby replaced and superseded by Revised Exhibit "D" attached to the First Amendment and incorporated herein.

It is mutually agreed that all other terms and conditions of Agreement Number 2015-145 shall remain in full force and effect.


