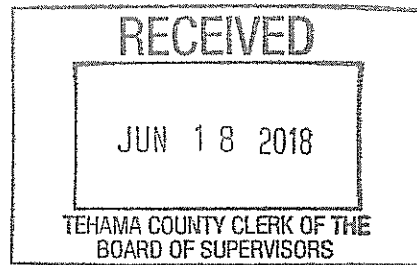

Damages or Injuries: right shoulder rotator cuff tear and will require surgery.


Amount of Money Claimed at this time: Within the jurisdiction of the Superior Court. Believed not to exceed \$10,000,000.00.
